There has been a generation of studies of the causes and consequences of the New Zealand Wars, but for their military course we still rely on a received version dating back in essentials to the nineteenth century. That is James Belich's contention. In a threefold narrative, he shows that the course and outcome of actions was often quite different from what we have learnt; he shows how, often within days of the events, the record was rewritten into a more palatable form; and he discusses the Victorian beliefs about racial conflict which lay behind the contemporary versions.

COMPULSORY ARBITRATION IN NEW ZEALAND

The First Forty Years

JAMES HOLT

James Holt, formerly Associate-Professor of History at the University of Auckland and briefly Government Historian, had intended to carry his history of New Zealand's industrial conciliation and arbitration system up to 1968, but had completed it only to 1932 when he died in 1983. This was, however, a logical cut-off date, and only minimal revision (undertaken by Professor Erik Olssen) was needed to make it publishable. In a narrative notable for its economy and clarity he shows how, in successive decisions, the Arbitration Court assumed a wage-fixing function far beyond anything envisaged by the founders.
