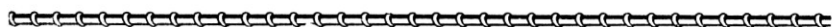

Australia and the Great Depression

C. B. Schedvin

This book provides the first full-scale discussion of the formation of Australian economic policy in the depression of the 1930s. The narrative is set in the context of the international economy between the two world wars and of the long-run characteristics of Australian economic development. Contrary to the widely-accepted contemporary version, the author finds that deliberate economic planning played little part in determining Australian depression policy. An important theme in the book is the relationship between the severity of Australia's depression experience and the structural shift towards manufacturing industry in the 1920s. For the narrative chapters on economic policy, the author has drawn on material from the Commonwealth Treasury, the Reserve Bank of Australia and the Bank of New South Wales. Includes seventeen line diagrams and forty-four text tables.
